8. I agree that any damage caused by my pet will be repaired by the Board of Directors and charged to the unit owner at the sole discretion of the Board of Directors.
9. I will not allow my pet to cause a noise disturbance of any sort throughout the property. Should noise be an issue, appropriate steps will be taken to remedy the situation.
10. Upon request, I will provide copy of current veterinary inoculation records.

**Based on a contravention of the above or subsequent concern within the boundaries of the existing By-Laws:**

The signee agrees that they will, upon written request, attend to the removal of the pet with 15 days notification from the Board of Directors and that any costs incurred by the corporation to ensure compliance will be at the cost of the unit owner.
